SETUP DATE/TIME: Friday April. 4th, 12 Noon - 5pm ONLY | CHECK-IN DATE/TIME: Saturday, April. 5th, 6am - 8:30am ONLY
ALL VEHICLES MUST BE OFF THE SHOW GROUNDS ABSOLUTELY NO LATER THAN 8:30 AM FOR THE SAFETY OF EVENT GUESTS

In order for the Jamboree to maintain both quality and variety of works, the Committee may limit repetitions of the same crafts and vendors. If your work is not accepted, the application fee will be returned. The \$5.00 processing fee is non-refundable. Booth space size will be approximately 10' X 10'. **NO electric hook-ups are available.** Vendors provide their own tents, tables, chairs, sturdy display racks, shelves, etc. Vendors will receive a wrist band and a parking pass.

1. Obey one way and all other signs.
2. **For safety purposes, vehicles must be moved off the show grounds no later than 8:30 am on Sat. & Sun. and are not permitted back on the grounds until 5:15 pm Sat, 4:15 pm Sun. All vehicles must park in the assigned parking area, no parking on show grounds.**
3. If you have an emergency that requires you leave during the show—locate a staff member or volunteer with a radio and ask to be escorted on and off of the grounds.
4. **ALL TENTS MUST BE secured with weights or stakes.** Any damage caused by unsecured tents will be the responsibility of the person who's signature is on the application. Be prepared for sun, wind, rain, and insects. When two people share one booth with two different products (for example: wood and sewing) each exhibitor must pay the application fee. A two-person team producing a single product may qualify as single exhibitor. Please explain the finished product.
5. If this is your first event with us, please send a minimum of three (3) close-up photographs of your work or items to sell and one (1) close up of your display. Submit via the email address below or via text at (386) 244-9125
6. All arts and crafts vendors are restricted to original works, designed and hand-crafted by the applying artist. Artist must be present at show.
7. Reselling of Direct Sales/Commercial items will be accepted on a limited case by case basis and cannot be combined with handmade arts and crafts vendors. **NON PROFIT VENDORS ARE PROHIBITED FROM ANY SALES OF ANY KIND.** Donations allowed.
8. Pornographic material in any form is strictly prohibited. Committee holds the right to define pornographic.
9. Acceptance is a commitment to the event for **BOTH DAYS and FULL SHOW HOURS of the Frolic.** Vendors who agree to vend for both days, but fail to do so risk no longer being invited to future events. **Vendors may not shut down before the event ends.**
10. **No refunds in case of inclement weather or cancellations.**
11. Register early. **Placement is not guaranteed** and is solely at the discretion of the Jamboree committee.
12. **Booth placement is at committee's discretion. Placement requests will be considered if at all possible; spaces CANNOT BE RESERVED NOR GUARANTEED.**
13. Vendors are responsible for collecting and forwarding the 6.5% Florida Sales Tax of our area to the Dept. of Revenue.
14. **Only Service Animals are allowed on the grounds.**
15. When any rule is violated, the Committee reserves the right to ask the offending vendor to leave the show or remove said offense or violation.
16. The Settlement is not responsible for loss or damage, or for exhibits/items left overnight.
17. No overnight camping, even in self-contained vehicles, will be allowed. Camping facilities are located nearby in Astor.
18. Vendor grants permission for the Settlement to use any photographs or publicity while an event participant to be used in conjunction with future Settlement publicity
19. Electricity and water resources are very limited. Self-contained booths are required. Because of noise control for the public, generators must have **quiet operation.** Noise must not interfere with music and/or storytelling stages.
20. No alcoholic beverages are permitted on Settlement grounds.
21. Vendor is responsible for clean-up of its area. All areas are to be kept neat, clean, and orderly at all times. No dumping of liquids, water, grease, or food waste is allowed. **A Clean-Up fee of \$500 will now be assessed for violators. No exceptions.**

ADDITIONAL FOOD VENDOR Rules & Information

22. Food Vendors are required to present proof of insurance naming the Pioneer Settlement for the Creative Arts, Inc. as additional insured. General liability and product liability are required. Limits of liability should not be less than \$1,000,000.00.
23. Food Vendors are responsible for all health, fire, and safety codes adherence. Vendor must comply with the guidelines of the Florida division of hotels and restaurants.
24. Each Food Vendor must provide a minimum of one 30-gallon trash can with liners and a lid. It is the vendors' responsibility to empty the container when full.

Please ensure your entire party will adhere to these procedures before applying to this event.

Rules will be strictly enforced by our Settlement staff & specially assigned volunteers.
